- Update George

  - Ejection report
    - Assistant coach need to get names of ejections at the game
      - Do not contact school personal
    - Ejection argument over a check swing
      - Unacceptable act by coach
      - Ball/strike issue
      - No restriction please follow 5 step process
    - Balk call when the wind blew the hat off and pitcher tried to catch it
      - No harm, no foul
    - No ejection for hitting 2 batters
    - No warning before the game starts
      - i.e. for jewelry
      - reminder is fine but not a warning
    - more in the bulletin

#### **CHSAA Report**

- CHSAA update Bert
  - Waiting to submit variances to the state
  - Expect mask wearing into and out of facility
    - wear at plate meeting
    - schools responsible for players/coaches wearing masks not umpires
  - o capacity limits at sites will be by county mandates
  - final details will come before the season starts (maybe a couple of weeks before the season)
  - o going to request 18 games
  - o Registration will have the COVID-19 waiver form sign off
    - Will we have enough umpires to cover games?
      - If we don't, games will be prioritized based on numbers
  - No testing/contact tracing/vaccine requirements for HS
    - Health department will provide direction on questions

      - In process to putting everything together that will include:
        - Will film some situations

        - Balls should be compliant we will not suspend games

- Post season awards John/Committee
  - Committee formed
    - Lead: John
    - Committee: Terry, Ryan, Chuck, Greg
      - Committee agreed:
        - Following survey guidelines of approximately 80% members said to spend less than \$100/umpire which is in the approved budget
      - Committee recommending:
        - Provide the 45 Semi-Finals and Finals umpires with polo shirts
          - Gene/Great Call (G8Call) will do a 3-year agreement for \$800/year toward 45 polo shirts with the Great Call logo on the shirts along with a mention at the master clinic

- One quote for 50/50 shirt with CHSBUA logo and Championship Umpire on the chest and Great Call (GR8) on the sleeve for \$25/shirt
- Another quote for performance shirt with CHSBUA logo and Championship Umpire on the chest and Great Call (GR8) on the sleeve for \$33/shirt
- Committee to review and proceed with one of them
- Provide the 15 Final umpires with
  - o Order form for selection of one of the following:
    - Plaque and CHSBUA hat with Championship umpire added to the back of hat
    - Ring (subsidized) the umpire would pay \$150
    - Jacket (Black pullover shell with Blue stripes)
    - Plaque and on field umpire shirt (black or light blue)
    - On field umpire shirt (black or light blue) and CHSBUA hat with Championship umpire added to the back of hat

  - Outcome: Committee recommendation adopted including the forthcoming committee decision about which shirt will be purchased
- Golf Tournament 8/16/20 fundraising update John/committee
  - Committee created to identify possible uses for funds gained from activities
    - Lead: John
    - Committee: Greg, Ryan, Terry, Stephan
    - The committee agrees:
      - We must have a predetermined idea about what we should be using any funds from activities
      - The specific uses have to be identified
      - What do we want to do that don't budget for?
    - The committee recommends:
      - Rolling over golf money from August 2020 event for the 2022 season
        - Golf tourney fundraiser is planned to occur in late 2021
      - Provide a meal for each area's 2022 kickoff/welcome back/recruitment meeting
      - Run area/group/combined area clinics as appropriate/possible (gym and/or field) for 2022 season training
        - Recruitment for attendance
        - Pay clinicians to teach and evaluate
        - Progress report on attendees
          - i.e., moved from 1<sup>st</sup> weekend to 2<sup>nd</sup> weekend playoff games
          - Showcase progress to state membership
      - An area could request money to do specific training or event to advance umpires
    - Motion: Dave Granzella
      - 2<sup>nd</sup>: Bob Richardson
      - Outcome: Committee recommendation adopted
- Years of service award Ryan
  - Absorb CS pin program

- Pins for every 5 years
  - About \$5.10/pin with original set up
  - Could wear on lapel or hat
  - 117 pins = \$510
- Could we get for cheaper?
- Area Directors should talk this up as resulting in retention
- Motion: Ross Chase
  - 2<sup>nd</sup>: Richard Gillenwaters
  - Outcome: move forward with pin program to include cost review
- Modified Season Calendar Draft (enclosed) Greg
  - Updated calendar with latest dates and information
    - We should be aware that <u>dates will be fluid</u> until we get closer to the season
    - Preseason HS season/club games
      - Some/many teams are planning to play before the HS season
        - They will be asking for umpires (just like summer ball)
        - Opportunity for training
          - New umpires
          - 3 person mechanics
  - BOD agreed that the following <u>must</u> be met for post season eligibility requirements for 2021 only
    - Register and dues paid extended to 3/15/21
    - MC attendance yearly requirement?
      - Recommend that umpires review this year's MC
      - We will take up changing the constitution to become yearly in the future
    - Post season test minimum of 85% by 5/2/21
  - o BOD agreed that there will <u>not</u> be any requirements for the following:
    - Area Meeting attendance requirement?
      - None will encourage attendance to share information
    - 3-person training requirement
      - None discussed
    - Varsity (max 18 game schedule)/Sub Varsity games requirement?
      - None required
  - o Motion: Bob Richardson
    - 2<sup>nd</sup>: Stephan Brown
    - Outcome:
      - For 2021 post season eligibility requirements: Register and pay by 3/15; MC viewing recommended; 85% score on post season test.
      - No requirements for area meeting attendance, 3-person training or umpiring any varsity or junior varsity games
- Umpire registration progress update
  - As of 2/15, 100 umpires have registered
    - Reminder that the 3/15 registration date is for post season eligibility
  - Monica to send a reminder to the membership on 2/22
    - Would be helpful for ADs to reach out to their area's members with a reminder
    - Terry to provide outstanding umpire lists to the ADs

- Referee Designated Hitter publication Greg
  - o Digital copies are available in limited quantities at no cost
    - Access via Referee Digital Portal (RDP)
    - Instructions provided to interested umpires pending access from Referee
    - Tabled until March 2021
      - Will do a survey in March to gather interested umpires to provide access
  - Publications have been ordered for new umpires only in 2021/22
    - They will be distributed to the areas with new umpires
      - Distribution in March once we get the new umpires registered
      - ADs to provide Greg with number/names of new umpires and will be sent to each area

- Post season eligibility, ranking and availability spreadsheet (draft enclosed) Greg
  - We agreed to use this last year
    - If anyone needs help with the spreadsheet use or filling out, contact Greg
  - Final worksheet will be provided to include the eligibility decisions around the 1<sup>st</sup> of May
  - o We may need to be flexible with how the post season assignments are done this year
  - The spreadsheet tracks:
    - All postseason eligibility requirements
    - ADs insert umpire ratings for classification, best position, last weekend to work, crew chief, last championship umpired
    - By mid-May, ADs collect availability for the 3 playoff weekends
      - Understand that there might be 5% who make changes
    - Identify any travel limits and/or blocked schools

- There are 1A/2A districts games that need to be supported that coincide with the end of the regular season
  - We have to plan to provide umpires for these games
- We should communicate with umpires as soon as possible for SF and Final's assignments
- o Need to make sure everyone is on the same page prior to communicating
- 2021 Rules Test Plan Greg/George
  - ~ 95% of the test questions are from past NFHS tests
    - Others from Referee quizzes or created to cover new rules
  - o We had 10 umpires review the multiple-choice questions in the database
    - Each reviewed about 20 questions each
      - The final database has 225 questions
    - This corrected any typos
    - Reworded/eliminated any questions and answers that were not clear
  - o Ross created the two person mechanics T/F questions
  - o Using the same three person mechanics questions from last year's test
  - This plan requires umpires to take only one test
    - Umpires make their choice on which test to take
    - 3 chances to pass
  - Umpires only wanting to do <u>regular season games</u> including new umpires (unless an out of state transfer that wants to be postseason eligible) will have an 80 T/F rules questions AND 20 <u>two</u> person mechanics questions combined in one test. 100 questions total.
    - Required to pass test by May 2
      - This test would be available until June for any late joining umpires (i.e., after the season begins)
    - Note: post season interested umpire may take this test as preparation or for additional review
  - Umpires wanting to be <u>playoff eligible</u> including an out of state transfer will have a 60 multiple choice rules question test AND 20 <u>three</u> person mechanics questions combined in one test. 80 questions total.
    - Required to pass test by May 2
- 2021 Inactive umpire status
  - A question from an umpire about 2021 inactive status and fee prompted us to review and discuss:
    - Our Constitution/Bylaws under Art IV Membership, allows for inactive status for a medical issue, or a leave of absence and the cost of this is \$50.
    - With our veteran umpire dues only being \$10 for 2021, the following was approved by the Executive Committee:
      - CHSBUA "waives" the inactive status dollar amount and grants any
        umpire for the 2021 season, for whatever reason that wants to "optout", inactive status with no fee charge. This would allow them to
        return the following year with regular/normal registration fees.
  - "Opt-out" requests should be received by the Area Directors and forwarded to Terry and Monica for tracking
