 - Ross received approval from Adam to have 4-person umpire crews for 2022 championship games
 - Need to have post season umpire nominees by Sunday, 4/24
 - Must confirm umpire availability for 5/19 (1A), 6/4 (2A-5A)
 - Please provide below information for each candidate:
 - Umpire Name
 - Classification Level (1A-5A)
 - Best position (plate/base)
 - Comments on recommendation
 - Selection committee finalizes 20 championship umpires by Sunday, 5/1
 - We should communicate with umpires as soon as possible for Final's assignments
 - Need to make sure everyone is on the same page prior to communicating
 - Expect the Committee to include: Ross, Ryan, Greg, George, A1 AD TBD, with support from Fred and Chuck
 - Who else?
 - Will need to do some review/training/preparation with selected umpires
 - Training may include having a 4-person crew at a local area game in early May to allow guys to be on the field.
 - Could combine area umpires for these games
 - 0 1/10; 2/3/4/5/6; 7/8/9/10; 11/12/13; 14/15/16
 - CHSBUA probably would have to pay for 2 of the 4 umpires at these games.
 - Mechanics manual review could be accomplished by using the 2021 CCA 4 person mechanics manual which was sent on 3/19 (manual attached)
 - Additional training may include watching this YouTube video (25 minutes) about 4 person mechanics
 - <u>https://youtu.be/WE5q1QEKvFw</u>
 - In general, the mechanics manual and video line up with each other.
 - If we use the CCA 4 person mechanic and video as our guide for this postseason, we could decide after the season is over if we want to make any adjustments
 - Currently have 216 mechanics manuals (maybe 3 years' worth for new umpires)

Rules Interpreter Report

- Updates George
 - Media area clarification
 - If photographer was authorized to be there and didn't intentionally interfere whether in the media box or not, the ball remains live
 - Time Limit Ross
 - Ross suggested that CHSAA implements a no new after 1:45 with a drop dead of 2:00.
 - Ross stressed that this needs to be done for the 2022 season.

- Adam agreed that this would be beneficial but this would have to go thru the baseball committee (selected Athletic Directors and Coaches)
 - Meeting occurred on January 6th and Kennie attended for Ross
 - CHSBUA needs to receive the minutes of the baseball committee meeting
 - Ross requested a copy and hasn't received a copy
 - The committee voted unanimously to have "no new innings after 2 hours on all sub varsity games."
 - This will not be a drop-dead time, and games may end in a tie.
 - Leagues may adopt rules for shorter times but not longer.
 - The baseball committee sent this to CHSAA for final approval. This will be implemented in 2023 season with recommendations that CHSAA implement this into 2022 as an "experimental rule."
 - We are waiting for CHSAA's decision for the 2022 season
- Discussion about driving a time limit in 2022 at the plate meeting
 - Many areas have been doing so for a few years
- Umpire registration progress update Terry
 - o Multiple reminders sent to the membership over the past few months
 - As of 1/12/22 (post season registration eligibility) is approximately 260 umpires registered
 - Might be tough to cover post season with these numbers depending on registered umpire's availability
 - As of 1/25/22 291 umpires registered (reference: 2021 340 registered umpires)
 - Includes 31 new umpires
 - \circ ~ Some discussion about using one umpire on varsity games is coming
- Master Clinic 2022 Ross
 - $\circ \quad \text{2022 Master Clinic changed to virtual}$
 - Committee Ross (chair), Kennie, Ryan, John, Bill (added to committee 10/10)
 - Ross is working with Adam, Tom, George and Gene (Gr8) to get portions recorded and will be ready for 2/6/22
 - Will include anything from the BOD meeting if needed and will publish on 2/9.
 - Due date by 3/5
 - Highlights of MC shared
 - Emphasis on completing game reports for ejections and unique situations
 - Follow 5 step process
 - Power points for new topics will be emailed to BOD

 - Area 4 La Junta: Vacant

 - This combination of areas will be experimental to see how this season goes
 - Chuck will provide feedback on how this goes
- 2022 Test Discussion Greg
 - Agreed to keep format from 2021 test
 - 1 membership/new umpire test (100 question test; 80 T/F & 20 2 person mechanics)
 - 1 postseason test (80 question test; 60 multiple choice & 20 3 person mechanics)
 - Smaller database of questions
 - ADs were invited to participate in picking questions
 - Thanks Gary, Pat C, Mike, Bill for participating
 - The same 60 multiple choice questions for all umpires with only 2 chances to pass the test
 - \circ Both tests were submitted in December to Arbiter for posting on January 14th
 - Communication about the test formulation to the membership to ensure they understand more about the test and that it is made up from NFHS test questions and not meant to be a "stump the umpire" test
 - Communication sent on January 21st
 - There is one question that we will need to give credit toward
 - Greg included the bad question in the meeting minutes (enclosed)
- Golf Tournament update John More details will be provided as the team wraps up their work
 - John delivered the 2021 check for \$2247.50 (with a deposit to the course of \$500) to Terry the first part of December
- HOF Banquet BOD discussion
 - Agreed to nominate next members at 1Q22 meeting
 - We should look at inducting umpires
 - Current list of HOF members posted on the CHSBUA web site
 - We agreed to have the next ceremony in 1Q23 in conjunction with MC weekend
 - Need to look to have it at a hotel for convenience of those traveling in
 - Need to have nominations
 - These people were nominated at 1Q20 meeting
 - Joe Bonaquesta (coach in Pueblo)
 - Dan Weikle still active not eligible
 - Dave Baker Terry to find previous nomination
 - We should look at others to include some recent retirees
 - Michael Doohan nominated by Pat C on 11/1/21
 - Joey Borjon (post humorous) by Pat G
 - Need bios from Terry, Pat C, Pat G by 2/28 sent to Greg for distribution
 - Vote at 2Q22 meeting
- HOF organizing committee Greg
 - Discuss creating a separate/permanent HOF organizing committee Greg

- Organize yearly event through regular meetings throughout the year
- Engage past HOF and CHSBUA members
- Engage current CHSBUA membership
- Create a virtual HOF on website with bios and pictures of HOF members
- Agreement to have Greg lead a separate committee for the HOF

 - Ross to be added

 - Will go to bank by 2/25

- Gr8-Call.com Sponsorship Chuck
 - Wants to discuss lack of traffic and purchases at Gr8-Call
 - Chuck reminded BOD to investigate
 - Gene provided flyer sent to membership and Terry posted on training page
- 2020 Golf Money Distribution update
 - Terry sent an email explaining our quandary about distributing the 2020 golf money to the Executive Committee with an ask to engage Area Directors to solicit suggested solutions off line so that we could limit time spent in this meeting.
 - The overall goal is to recognize the umpires
 - Recommendation to distribute money as of 3/5 registration numbers
 - ADs to submit expense report for reimbursement of activity
 - Motion John Juranek
 - 2nd Bob Richardson
 - Passed
- BOD reviewed the following on what <u>must</u> be met for post season eligibility requirements for 2022 only – BOD
 - Consensus (in blue) on post season eligibility requirements for 2022 only
 - Register and dues paid by 1/12/22
 - MC attendance once every 2 years
 - Recommend that umpires review this year's MC (virtual)
 - Post season test minimum of 85% by 3/7/22
 - Area Meeting attendance requirement?
 - How many meetings?
 - Ensure members are active

- AD's discretion about meeting requirements for each area
- Should meeting credit be given for umpiring a scrimmage/pre-season game?
 - Only one credit for a meeting (not multiple credits)
 - AD's discretion about scrimmage credit
- 3-person training requirement
 - How best to provide?
 - How to provide timely training before the postseason?
 - Possible a state meeting to cover 3 person training as a supplement
 - Who to create and distribute?
 - ADs to provide local training
- Varsity & Sub Varsity games requirement?
 - How many Varsity and Sub Varsity games?
 - 10 Varsity games; 3 sub-V games with AD discretion on sub-V games
- Motion: John Juranek
 - 2nd: Bob Richardson
 - Outcome: Above 2022 post season eligibility requirements adopted
- Post season eligibility, ranking and availability spreadsheet (draft enclosed final to be sent mid-March with Registration, Test and MC results and with agreed upon post season requirements from the meeting) – Greg
 - We agreed to use this last two years
 - This was beneficial for assigning games last postseason
 - If anyone needs help with the spreadsheet use or filling out, contact Greg
 - Final worksheet will be provided to include the eligibility decisions
 - The spreadsheet tracks:
 - All postseason eligibility requirements
 - ADs insert umpire ratings for classification, best position, last weekend to work, crew chief, last championship umpired
 - By the end of April, ADs collect availability for the 3 playoff weekends
 - Understand that there might be 5% who make changes
 - Identify any travel limits and/or blocked schools
 - \circ $\;$ There are 1A/2A districts games that need to be supported that coincide with the end of the regular season
 - We have to plan to provide umpires for these games
